WHY JAMES LENOX HOUSE MATTERS

Troublingly, safe, affordable housing for older adults remains scarce. James Lenox House (JLH) is a bright spot, thanks to community and donor support.

Last Spring, NY1 named our Executive Director, Joe Girven, "New Yorker of the Week" for his leadership through the staggering complexity of protecting residents from Covid, and the remarkable, against-the-odds fact that not one of our residents has died of Covid. One resident interviewed

for the segment said simply, "Joe has saved our lives in the last three years."

Called a "sanctuary" in a Wall Street Journal article, JLH has been offering safe, independent, affordable housing through World Wars, Recessions, Pandemics. Its sister, Carnegie East House (CEH), opened in 2002 and likewise not-for-profit, offers enhanced services to those needing help with daily living. A key asset at both is superb, caring staff.

Critically, the health and wellness offerings at both Houses are linked to equally essential donor-enabled social engagement programs that keep our diverse community of older adults active and connected.

Going forward, we are putting in place plans to expand community access to our health-centric programs. opening our doors to more opportunities to enrich more lives and ensure that our Houses remain a vibrant part of our city. We hope you will continue to support us.

RESIDENT: ROSEMARIE ALDIN Madam Chef

Artwork, as well as books, hundreds of books, line the walls of Rosemarie Aldin's apartment, including ones by Jacques Pepin and James Beard whom she knew through her own career as a chef.

She didn't aim to become a chef, she says. Her love really was research, deep diving into topics, a passion that helped enable her husband's academic success. In her 40s, when she became a divorced single mother of two, she turned to cooking to "pay the bills" though her research skills also helped.

She worked with the chef, Felipe Rojas-Lombar, for instance, on his book, *The Art of South American Cooking*, praised both for its culinary diversity and for illuminating discussions on how particular foods fit into the fabric of meals. Other food-focused writing and consulting followed, for publishing houses as well as magazines such as *Good Housekeeping*.

On a parallel path, she stepped into hotel and restaurant kitchens.

Working her way up the ladder was hard. "I had credentials. I didn't have a culinary degree." Another barrier: women were rare

in the male-dominated world of top chefs. At last, a chef at the iconic Waldorf kitchens recommended her for the first of what would be a series of executive chef posts - including at celebrated restaurants and at Columbia Medical School where she famously created extraordinary daily buffets.

Finally, years of long days in hot kitchens took a toll, nudging her to more sedentary creativity: director of a modern art gallery, a segue from earlier volunteer work at the International Institute of Education where she had helped vet artists' grant applications and introduce galleries to new talent.

Now retired, she relishes time with her son in upstate New York, her Princeton NJ-based daughter, grandchildren, two sisters and nieces still living in her native Germany. She keeps her whisks nearby however, from time to time contributing to James Lenox House events. "It's wonderful to be able to live here," she says.

RESIDENT: DUANE WOOD A Well-Built Life

A photo of a lovely woman, centering a custom snow globe, has pride of place in Duane Wood's Carnegie East House apartment. That's Mary, the love of his life, his wife of 65 years. Widowed last year, he moved from Florida to New York to settle in just blocks away from his son whom he credits with not only finding and furnishing his new home but also, with a grandson, putting every possession into precisely the right place before he moved in. "I didn't change a thing," he marvels.

His delight in his new setting seems a continuation of a life well lived. Now 93, a handsome man with a gift for storytelling, he grew up in Flint, Michigan, flew 43 combat missions in the Korean War (crash landing once in a rice paddy), returned home where he met and, six months later, married Mary.

Grinning, he hands a visitor a 9-page factpacked biography on the history of his and Mary's families and their own life together. "Do this for your kids," he says. "They need to know their story."

Wonderful story. Just a glimpse. After joining Buick from which he would retire 40 years later, he and Mary bought their first house, really just a shell. They wired and plumbed and insulated it until it was livable. Building by hand became a joyful theme of their life together.

They hand-built a weekend cottage on Lake Missaukee which became their full-time home in retirement. They invented their own adventures, taking their two kids, Cindy and Craig, on many camping trips. They brought in snowmobiles, water skis and built their own tennis court. After putting their kids through college, they launched empty nest explorations including throughout the southwest, Australia, New Zealand, Europe. Along the way they adopted Mesa Arizona as their winter home, then began a



lively new golf-friendly life in The Villages in Florida. A good life, with more adventures to come.

HEALTH AND WELLNESS

Exercising Creativity

Knitting might not be top of mind when considering exercise activities.

But in fact, knitting is good exercise for hand-eye coordination. It's also good for the brain since it requires use of many parts of the brain at the same time.

Moreover, knitting regularly forces the brain and hands to work together to help maintain good motor skills. All good. There's more. Knitting also can improve and maintain hand dexterity and strength, helpful for improving one's grip, particularly relevant for older adults.

These benefits are cited by this year's two young Fordham Social Work interns, Colleen Scheuer and Molly McCullen. The knitting classes they introduced at JLH have delighted residents. So too have the Art (watercolor) classes and Journaling program.

Surprises are part of the appeal. For Art class participants a group trip to the nearby Metropolitan Museum of Art was organized. Molly's Journaling experience is that participants tend to be very supportive of others' efforts, whether they be humorous or

unexpectedly sad.

Each initiative lends itself to active and positive social interaction, vital to both mental and physical health. Each also can be a beneficial personal exercise. Knitting can be a curl-up-in-a-chair absorbing private pastime or a terrific social connector in which participants learn from and about each other.

The JLH intern partnership with Fordham University's Graduate School of Social Service has been in place for decades, each year bringing in fresh thinking and energy. The programs they bring are designed to be engaging and fun while critically, as Colleen put it, "encourage a sense of community and connection."

The Fordham program joins a deliberately eclectic array of health and wellness offerings, spanning Alvin Ailey's AileyDance for Active Seniors, Chair Yoga, Qigong classes, Shakespeare with Leo (professional actor Leo Schaff), NY Pops on the Patio, intergenerational Tech Help programs pairing middle school students with residents and often yielding what one resident called "a wisdom exchange".
